This is a **Request for Quotes** notification for the I-77 Rehabilitation - Design Build Project (Yadkin/Surry Counties) (NCDOT), proposal-due date, Tuesday, May 15th, 2018 at 4:00 p.m. (Turn-In Date/Time). **The Lane Construction Corporation** is bidding on this project and is seeking quotes from subcontractors and suppliers on portions of the work. Project is located along I-77 from the existing construction joint (approx. mile marker 78.4) just south of US 21 (Exit 79) in Yadkin County to Mile Marker 83.4 in Surry County including loop and ramp repairs at the US 21 BUS interchange (at Exit 79) and the NC 67 interchange. Availability Date: 6/25/2018 and Completion Date: 8/15/2021. There will be day and nightwork on this project. Davis-Bacon Wages.

This project consists of Roadway: earthwork/grading, trucking of materials, concrete paving, asphalt paving, pavement related hauling, demo of existing pavement, subgrade stabilization, pavement markings, traffic signs, geotextiles, miscellaneous concrete flatwork, aggregates, guardrail (install/repair), temporary barrier, erosion control, seeding, work zone signs and many other scopes of work and opportunities.

Lane Construction welcomes participation from NCDOT certified DBEs on this design-build project (with a DBE goal of 12%). The Lane Construction Corporation is willing to break out parts of this contract's work items into economically feasible units to facilitate DBE/subcontractor participation. Lane Construction is willing to negotiate in good faith with interested DBE subcontractors, and Lane will not reject DBEs, as being unqualified without sound reasons based on thorough investigation of their abilities. Lane Construction will work with minorities on issues related to bonding, insurance, lines of credit and equipment.
